Astor's flagship strategy takes a macroeconomics-based approach to asset allocation using the proprietary Astor Economic Index® (AEI).

- Pursues the ability to offer risk mitigation by strategically reducing risk as the economy weakens in order to minimize portfolio exposure to potentially
 wealth-destroying events.
- Seeks total return through a combination of capital appreciation and income.
- Attempts to produce more favorable risk-adjusted returns (higher average return and lower volatility) than broad equity and alternative benchmarks by increasing
 allocations to risk assets during times of economic strength and replacing risk assets with defensive positions such as fixed income during periods
 of economic weakness.

The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
